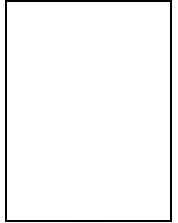

Organisers

This event is being organised by The Rotary Club of Dartmoor Vale. Road race permits are being obtained from English Athletics, under the auspices of RunBritain.



The Races

Marathon

An undulating 26.2 mile two-lap run in the shadow of Dartmoor.

Half Marathon

An undulating 13.1 mile run in the shadow of Dartmoor.

10K Road Race

A fairly level 10k run around Kingsteignton. The 10k will start at 9.30 am to separate it from the other races.

Courses

The courses are between Kingsteignton (near Newton Abbot) and Chudleigh, in the shadow of Dartmoor. They are entirely on tarmac, with the Start and Finish at Sibelco's East Gold Works. The races will be controlled by marshals, with water stations, first aid stations, distance markers and time clocks. Road Race Permits are being obtained from UK Athletics. The courses have been formally measured and certified accurate. They are suitable for wheelchair users, though there is a steep hill on the Marathon/Half Marathon course. We are looking into providing limited changing facilities, but cannot yet confirm that these will be available.

Time Limits

There will be a 5 hour time limit for the Marathon and Half Marathon and 2 hours for the 10K Road Race. We reserve the right to require Marathon runners who have not started their second lap by Noon to retire.

Entry Conditions

Detailed Entry Conditions will be found at http://www.dmvmarathon.org.uk/images/entry_conditions.pdf. We ask that you read these carefully.

Prizes and Trophies

Trophies will be awarded to the first 5 men and first 5 women in each Race. Trophies will also be awarded in the age categories M40, M45, M50 M55, M60 and M70, F35, F40, F45, F50, F55 and F60 dependent upon the numbers of runners in each category. A runner may only win one trophy. All finishers will receive a custom-designed medal and memento.

Paperwork and Chip timing

Joining Instructions and other paperwork will be e-mailed to you automatically when you register or when we log your paper entry - please contact the Race Secretary if you do not receive these.

Chip timing will be provided for all three races by Full on Sport www.fullonsport.co.uk. Your running number and chip must be collected on the day from the Registration desk located near the Start of each race, so please aim to arrive early.



We expect to have the results on our Website before the end of Race Day.

Charity

This is a Rotary fund-raising event, with all the surplus going to charity. In ten years, we have helped raise over £260,000 for charity. If you raise any sponsorship, send it to us and we will donate it, plus recoverable Gift Aid, to your nominated charity. In early 2018, we will also donate to them a share of the overall surplus. We added 50% in 2016, so please run for your charity and make a real difference.
